 - (ii) if the share capital of that body is more than one class, the total nominal value of the shares of any one class in which you, or your partner, have a beneficial interest exceeds one hundredth of the total issued share capital of that class.

Securities means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000, Section 8, and other securities of any description, other than money deposited with a building society.

8. Other Interests

This means any other interest that you or your partner may have such as membership or management of other bodies including bodies to which they have been appointed by the Council, other public authorities (such as Hampshire County Council, a local Parish Council, Hampshire Fire and Rescue Service, Office of the Police and Crime Commissioner for Hampshire etc), or similar bodies, charities, bodies to influence public opinion and trade/professional unions.

(d) knowingly or recklessly provide information under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act which is false or misleading;

is a criminal offence under Section 34 of the Localism Act, punishable by a fine not exceeding level 5 on the standard scale (currently £5,000), and disqualification as a Member or Co-opted Member of Fleet Town Council or any other relevant authority for a period not exceeding five years.
